

## ASSOCIATE SENIOR FELLOWSHIPS, FELLOWSHIPS, SCHOLARSHIPS AND AWARDS (non-stipendiary)

FOR RESEARCH ON ANY ASPECT OF THE SOCIAL, RELIGIOUS, POLITICAL AND ECONOMIC CULTURES OF THE ITALIAN PENINSULA, AND THEIR WIDER TEXTUAL, VISUAL AND MATERIAL DISSEMINATION AND RECEPTION FROM EARLY PREHISTORY TO THE MODERN PERIOD

THE BRITISH SCHOOL AT ROME is a centre of interdisciplinary research excellence in the Mediterranean supporting the full range of arts, humanities and social sciences. We create an environment for work of international standing and impact from Britain and the Commonwealth, and a bridge into the intellectual and cultural heart of Rome and Italy

---

This is a **new opportunity**, open to those for whom the residential aspect of the other awards that the BSR offers is not feasible, who are in receipt of other grants or means of support that will allow them to spend a prolonged period in Rome.

An **ASSOCIATE SENIOR FELLOWSHIP, FELLOWSHIP, SCHOLARSHIP AND AWARD** (non-stipendiary) offers:

- formal affiliation to the BSR for a period of between three and twelve months (late September 2021–late September 2022)
- access to opportunities open to residential award-holders (for example, permit requests, site visits, Italian lessons, communal IT facilities, internal workshops and lectures)
- eight lunches per month free of charge; and the option of signing in for other meals at the prevailing rates
- preferential access to the BSR's Library.

The BSR acknowledges the support of the British Academy towards its awards scheme.

## Scheme eligibility

Applicants must meet the eligibility criteria for one of the categories set out below:

- **Associate Senior Fellowship:** An established scholar, normally in post in a UK university\*. Period of tenure: minimum of three months.
- **Associate Fellowship:** An early career scholar, normally within three years of the award of the doctorate at the closing date for applications (so awarded no earlier than January 2018). Applicants who were awarded their doctorate before this should note that progression through other research fellowships or assistantships and teaching posts will not normally be considered a valid reason for not meeting this criterion. However, someone whose career has been interrupted by, for example, parental leave, family commitments or illness, will be considered sympathetically. Applicants must be British citizens or must have been awarded their doctorate by a UK university\*. Period of tenure: more than six months.
- **Associate Scholarship:** An early career scholar intending to submit their doctorate no later than 31 August 2021 but awaiting their viva and award of the degree. Any such award will be conditional upon this submission criterion having been met. Applicants must be British citizens or must be completing their doctorate at a UK university\*. Candidates will not be permitted to take up the award unless they have submitted the thesis by the date specified above: candidates therefore are advised to be realistic about their work and the submission date. Period of tenure: more than six months.
- **Associate Award:** An early career scholar who has begun a programme of research in the general field for which the Award is being sought, whether or not registered for a higher degree. Applicants must be British or Commonwealth citizens; or must be studying or have studied at postgraduate level in a Higher Education Institution\* in the UK, having completed by October 2020 not less than four years of residence in the UK. Period of tenure: minimum of three months.

**Applicants for Associate Rome Fellowships, Rome Scholarships and Rome Awards should note that applications that are solely to revise a thesis for publication, without undertaking additional research whilst in Rome, are unlikely to be successful.**

## General conditions

1. All applicants must have at least a first degree at the time of application.
2. Proof of nationality and/or residency may be required.
3. Preference may be given to applicants attached to, registered at or working at a university in the UK or the Commonwealth.
4. Applications must be submitted on the appropriate application form.
5. The awards will be tenable in the academic year (late September–mid-September) 2021–2.
6. The BSR is committed to offering opportunities to the widest possible range of projects and people within the BSR's remit specified above.
7. Normally two successive awards for the same project will not be considered.
8. Associate Senior Fellows, Fellows, Scholars and Awardees are expected to abide by the BSR's Research Ethics Policy (<http://www.bsr.ac.uk/site2014/wp-content/uploads/BSR-Research-Ethics-Policy-September-2014.pdf>) and Code of Practice (<http://www.bsr.ac.uk/site2014/wp-content/uploads/2019/11/BSR-Research-funding-and-code-of-practice-app0319-1.pdf>).
9. Associate Senior Fellows, Fellows, Scholars and Awardees are required to submit a report on their research within two months of the end of their award, and are requested to keep the BSR informed of future progress. Those whose tenure is six months or more may be requested to provide an interim report.
10. Associate Senior Fellows, Fellows, Scholars and Awardees are encouraged where possible to give *Papers of the British School at Rome* first refusal on any papers arising from the research undertaken at the BSR. *PBSR* is an open access (green) periodical published by Cambridge University Press. Publication with gold open access can be arranged on payment of an author/project fee.
11. Associate Senior Fellows, Fellows, Scholars and Awardees are asked to donate a copy of any publications arising from their research whilst holding a BSR award to the BSR's Library.

The BSR reserves the right to alter any aspect of the Associate Senior Fellowships, Fellowships, Scholarships and Awards.

### Selection criteria

In making an appointment to an award the Faculty of Archaeology, History and Letters will assess all applications using the following set of criteria:

1. The academic merit of the applicant judged by his/her previous record and references, including her/his prospects of making a future contribution to scholarship.
2. The suitability of the project for the BSR, bearing in mind its location, current research pathways, resources and access to resources.
3. The inherent academic significance and interest of the project proposed, and the feasibility of completion to the timetable stated.
4. The suitability of the candidate to contribute to the academic community of the BSR and the need to ensure a reasonable balance between different disciplines and chronological periods within the BSR's academic community.
5. The role of the Fellowships, Scholarships and Awards in promoting Italian studies in Britain and the Commonwealth.

The Faculty's decisions are final. Feedback cannot be given on unsuccessful applications.

### Equal opportunities

The British School at Rome is committed to a policy of equal opportunities in its appointments and awards policy and in the way it offers access to all its facilities and services.
